

# Seventeenth Annual Diamond Valley Lake Invitational

Hosted by: Dartmouth Knights

**When:** Thursday, November 9<sup>th</sup>, 2017

**Where:** Valley Wide Recreation Aquatic Center, 1801 Searl Parkway, Hemet 92543  
(off of Domenigoni)

**Time:** 9:30 am – 12:30 pm (self guided course tour, must be off course by 9:15 am)

**Who:** Boys and Girls in grades 6<sup>th</sup> through 8<sup>th</sup> (six separate races)

Race Order: 6<sup>th</sup> grade girls – 9:30    6<sup>th</sup> grade boys – 9:55  
7<sup>th</sup> grade girls – 10:20    7<sup>th</sup> grade boys – 10:40  
8<sup>th</sup> grade girls – 11:00    8<sup>th</sup> grade boys – 11:20

**Races will be run ahead of schedule, if time allows.** Meet is held rain or shine. Meet officials are allowed to cancel/postpone the meet for unseen circumstances.

**Course:** 2.0 miles primarily on a dirt road. A few rolling hills and 1 large hill. Finish line is on grass.

**Fee:** \$35.00 per race or \$15.00 each athlete

**\* Maximum of 35 athletes per race, a \$5.00 fee will be charged for each registered athlete over 35 in a race. You must pay \$5.00 per athlete over 35 per race regardless if the athlete races or not. This rule has been added to cut down on unused chips and tags.**

#### **Awards:**

- Plaques to top three teams in each race.
- Trophy to top male and female team (all grades combined).
- Medals to top 15 finishers and ribbons 16<sup>th</sup> through 25<sup>th</sup> place in each race.

**Scoring:** top 5 score, need at least five for a team

**Concessions:** a full concession stand will be available with food and beverages.
