## LAGUNA BEACH HIGH SCHOOL TRACK FRIDAY, April 1, 2022 5:00 P.M. – 8:00 P.M. CHECK IN BY 4:30 P.M.

This meet is open to boys and girls who reside or attend school within the Laguna Beach Unified School District boundaries and who were born in or after the year 2005. All divisions of competition are determined by year born. Please find the appropriate division on the official entry form and check the events you wish to enter. Participants may enter a maximum of three (3) events.

**TO ENTER**: Parents must register online at <a href="www.lagunabeachcity.net">www.lagunabeachcity.net</a> or submit a completed entry form together with the \$17 per child entry fee to the Recreation Division (380 Third St.) by Thursday, March 31st, at 4:00 P.M. (or \$22 at the event). Pre-registration is highly encouraged.

**Barefoot running, spikes and cleats are NOT allowed.** All equipment will be provided. NO starting blocks will be allowed. Medals will be presented to  $1^{st} - 3^{rd}$  place finishers, and ribbons for  $4^{th} - 6^{th}$  place finishers in each individual event.

Boys and girls who place  $1^{st} - 4^{th}$  in any individual event qualify to join the Laguna Beach Track Team that will compete in the Orange County Municipal Athletic Association (OCMAA) novice track meet on Sunday, May  $17^{th}$ . Registration for the OCMAA meet will be available onsite after the Laguna Beach Track Meet. If your child qualifies and is interested in participating in the May  $17^{th}$  track meet at Mission Viejo High School, please bring a photocopy of your child's birth certificate or passport with a check for \$15 payable to the *City of Laguna Beach*.
